## **By-Laws Voting References**:

- 1. Voting Members (Article III, Section B) "A Voting Member shall be at least thirteen (13) years of age, shall have been a Member for sixty (60) days, shall be an active participant having given time, and shall have pledged or given fair share support in the current fiscal year (or obtained a waiver)."
- 2. Quorum Requirements (Article V, Section B) -- "Thirty-three percent (33%) of the number of Members as of one month prior to the meeting shall constitute a quorum. ... Absentee voters shall not be counted in determining a quorum."
